In order to accommodate the operations of the Maryland General Assembly this session, all budget hearings will be conducted virtually and jointly between APP and B&T and the various subcommittees.

Hearings for APP and B&T full committees will be held at 1:30 p.m. on Tuesdays.

Operating budget hearings for subcommittees in both houses will be held at 1:30 p.m. on Mondays, Thursdays, and Fridays.

Capital subcommittee hearings will be on Tuesdays following full committee hearings.
