Agency budget hearings will not be heard jointly this session. House will conduct hearings virtually. Senate will announce its meeting procedures prior to the beginning of session.

House – Location: Fully virtual. Times: Mon 3pm, Wed-Thu 1pm, Fri 1 pm (Full Committee). Capital times: Wed 4pm.

Senate – Location: TBD prior to the beginning of session. Times: Mon & Thu 1pm, Fri 11:30am or immediately following session, Tues 1:30 pm (Full Committee).

Capital times: Tues following Fulling Committee.
