- 1. Welcome by Dr. Timothy Chandler, Interim President of Towson University.
 - a. Welcomed the group to their newest building, the SECU Arena.
 - b. 2000 TU students participated in their most recent cleanup event.
 - c. This is the 150th year of the university, there will be many events during the celebration.
 - d. TU receives over 22,000 applications for 4,400 freshman spaces.
 - e. Shared Governance is very important and will be the most important thing we will need to address in the upcoming years. He suggested keeping an eye on the North Carolina State Legislature as this is also a topic in their state. He also recommended that staff continue to offer your best advice to your campus.

 - b. Chancellor's Council Meeting
 - i. Effectiveness & Efficiency 2.0 purposes was to prove to the legislature that we could manage our own business. This has actually enabled the system to leverage more state funding. Looking for was to create new business practices.
 - ii. May 15th more updates on salary guidelines coming.
 - iii. Competitive State Funding looking at benchmarks and performance metrics. Currently reviewing 61 peers now.
 - iv. Sojourner Douglas College is being taken over by Stratford University.
 - c. BOR Meeting
 - i. Faculty BOR Award Meeting went very well.
 - ii. FY16 Budget 2% decrease over all after a 1.3% increase and leveling.
 - iii. COLA it is still not known whether or not the governor will spend the money allocated for the COLA.
 - iv. Merit Increase the house approved critical need for faculty and the senate approved critical need for both faculty and staff. What was the outcome?
 - v. Non-exempt and exempt pay program. There will be a special meeting on May 6th to discuss the non-exempt pay plan
- 5. USM HR Policy Update
 - a. Reminder that back in December, each institution was assigned policies to review for technical changes only. Please review and report changes by May 30th.
- 6. Chancellor's Liaison's Report Tom Hoffacker for JoAnn Goedert
 - a. Still looking for Rosario's replacement.
 - b. Wellness Plan getting questions answered
 - i. You can use an out-of-network doctor, however you won't be able to get the co-pay waived.
 - ii. Open enrollment will be online for the fall.

- 7. Board of Regents Staff Awards Update
 - a. There were a total of 35 nominations
 - b. A feedback survey went out to all the campuses.
 - c. The electronic process worked well.

- 9. Committee Updates
 - a. Benefits & Compensation -In the past 6 months we were able to get the list of discounts posted on the USM website thanks to Rubin Stevenson and Rosario. The committee is still collecting and updating data to improve the list. Keri Hickey and Gay Pinder have been working on a fair pay issue for position among staff employees. It is still an ongoing project (this is where a staff employee takes on or assumes a position but finds out they are not getting the pay that others in the same position are receiving). The child care topic is still in the processing plan. The committee is considering looking into the wellness plan laid out by the system.
 - b. Communications & Marketing- Trish Johnson (Bowie State) is now the chair of the committee. The committee will be working towards completing the second quarterly CUSS newsletter. Trish also plans to update the CUSS member list for the website and would like to take steps to clarify the CUSS elected member term to ensure that institutions do not pull members before their term is complete.
 - c. Board of Regents Awards & Recognition- The committee will submit the 8 final nominees to Bill. The committee has been reviewing the feedback from the surveys sent to institutions and CUSS members. The committee is considering several ideas including creating a professional development for those interested in the BOR awards process at the institutions. Sherrye was pleased to report that Coppin State would be proud to continue to host the BOR Awards Sharepoint site.
 - d. Legislative Affairs & Policy- The committee discussed feedback from the Annapolis Advocacy Day. Sasha suggested that planning needs to begin earlier and the visits to the offices needs to take place when the delegates and senators are available. Sherrye suggested using lunch as a way to attract the legislators to us instead, similar to what institutions do when they host a day in Annapolis.
