This gives staff and faculty the opportunity to ask questions.

We have kicked off a civility campaign which is one of our core values. We are working with Campus Safety to number all the "blue" emergency phones so that people's locations are known immediately. 5. Chancellor's Liaison Report

Good morning and glad we all made it to the New Year! We are off to a great start at the USMO.
 Dr. Jay Perman began as USM's 5th Chancellor on January 6th and we had a reception to start off
 the year – He spoke to his USMO colleagues, Presidents, and invited guests including the chair of
 CUSS and informed what drives him – excellence and civility. We are all excited to work with him
 and support him in his efforts.

- You should have received Andy Clarke's legislative update on Friday. Governor Hogan made public his FY 2021 budget for the USM on Wednesday. System and campus officials worked closely with Governor Hogan to ensure access to exceptional and affordable academic opportunities. The FY 2021 Governor's Allowance for the USM, if approved by the General Assembly, would provide \$1.548 billion in state funding for the USM Operating Budget—an increase of \$55 million or 3.7% over the FY 2020 funding level. Targeted enhancement funding initiatives such as the USM's system-wide Workforce Development Initiative (WDI) and other key items are included in the Governor's Allowance. The Governor's FY 2021 budget, as proposed, is an affirmation of Board of Regents' interests.
- USM efforts to make prudent business decisions to preserve quality, close the achievement gap, move towards degree completion goals, and advance Maryland's national and global competitiveness. The FY 2021 budget caps in-state resident tuition growth at 2% for the USM for the sixth year in a row. We will be watching the budget closely and I'll provide information as necessary.
- On December 20th, the Board of Regents have approved changes to our Supplemental Retirement Accounts which we will be implementing in the coming weeks. We will be bringing a 403b Roth as well as some administrative changes that will allow employees to save more for retirement. You will hear more from me and your HR offices in the coming months.
