**TOPIC:** USM Enrollment Projections: 2011-2020

**COMMITTEE:** Finance

**DATE OF COMMITTEE MEETING:** March 17, 2011

**SUMMARY:** Each year, the institutions update their enrollment projections for a 10-year period. The USM office works in concert with the institutions to insure the accuracy of these projections by providing them with supporting data and analysis of current and past trends. Any significant issues are resolved and the projection submission is modified where necessary.

Highlights of this year's institutional projections include:

- Overall projected headcount growth for the ten-year period is 24%, an increase from 152,581 to 188,497 students.
- Undergraduate enrollment is projected to expand 23% over ten years from 108,583 to 133,086.
- Graduate enrollment is projected to grow by 26% for the ten-year period from 43,998 to 55,411.

These projections represent a significant departure from the figures of the past three years by increasing planned enrollment significantly. They align with the USM Strategic Plan's goals to achieve 55% college completion and the Institutional Implementation Plans.

The Board is asked to approve the institutional projections contained in the attached report.

**ALTERNATIVE(S):** The Board may request changes in the projections.

**FISCAL IMPACT:** The fiscal impact of the projected enrollment growth will depend on many factors, including availability of facilities to accommodate increased enrollments, program of study of future students, availability of faculty, and in/out of state status.

**CHANCELLOR'S RECOMMENDATION:** That the Finance Committee recommend that the Board of Regents approve the enrollment projections as submitted.

# **USM Enrollment Projections Fall 2011 through Fall 2020**

## **Enrollment Projections: 2011 – 2020**

### **Overview**

The USM enrollment projections for the period of 2011 through 2020 are the first enrollment projections to be submitted since the approval of the new USM Strategic Plan, “Powering Maryland Forward.” The result is that these projections are a major departure from those in the most recent three years and reflect the institutions’ commitment to the access and completion goals called for in the plan. Importantly, because the new projections do represent such a substantial departure from past projections and institutions are still refining their response to the System’s new strategic plan, this year’s projections should be considered a “work in progress,” with subsequent changes possible as institutional plans and projections are further refined and aligned with funding scenarios and completion goals.

These current projections plan for greater, long-term growth within the System, rising to 188,000 by 2020. This includes substantial growth at most USM institutions. Despite this increased expectation for growth over the long-term, plans for growth in the near term are much more limited. Overall growth is limited to less than 1%, or less than 1,000 students, and if UMUC is excluded overall enrollment will fall by around 200 students (see Table 1).

### **The Report**

Tables 1 through 13 summarize the ten-year projections from 2011 to 2020 by institution, by student level, and by overall enrollment demand. The tables also provide detailed projections for each institution and for the entire System over this period.

Highlights of this year’s projections include:

- Overall headcount enrollment for the ten-year period is projected to increase from 152,581 to 188,497, an increase of 23.5%. Growth in headcount enrollment between Fall 2010 and Fall 2011 is projected to be 0.6%, an increase of approximately 968 students (see Table 1).
- Undergraduate headcount enrollment over the ten-year period is projected to expand from 108,583 to 136,086, a 22.6% increase by 2020. Growth in headcount enrollment from Fall 2010 and Fall 2011 is projected to be 0.7%, an increase of 738 students (see Table 1).
- The figures above include UMUC. If UMUC is excluded, then projected growth over the ten-year period will be 15.5% (rising from 113,004 in Fall 2010 to 130,493 in Fall 2020). Total undergraduate growth for the ten-year period for all USM institutions, again excluding UMUC, is projected to be 15.1% (see Table 4).

- In percentage terms, one-year growth in headcount enrollment is projected to be greatest at the University of Baltimore, UMES and UMUC (3.5%, 3.5%, and 3.0% respectively). Bowie, Frostburg, Salisbury, Towson, and UMBC are all projected to experience some growth (between 0.9% and 1.3%). Coppin is projected to have virtually no growth in Fall 2011. UMCP and UMB plan to reduce enrollment by 3.2% and 0.9% respectively in Fall 2011.
- One-year FTE growth is projected to be greatest in percentage terms at University of Baltimore (3.5%), UMES (3.5%) and UMUC (3.0%). Coppin, Frostburg, Salisbury, UMB, and UMBC are projected to experience some growth (between 1.0% and 1.7%). Bowie and Towson are projected to have little or no growth in FY 2012. UMCP's enrollment will shrink (-3.0%) (see Table 2).
- For the entire ten-year period, UMUC is projected to experience the greatest percentage increases in headcount enrollment, both at the graduate and undergraduate level (nearly 50% growth). Bowie, Coppin, and UMES are all projected to see very robust growth at both graduate and undergraduate levels (between 32% and 41% growth). University of Baltimore is projected to have strong growth (32%) with the majority of the growth concentrated at the undergraduate level (58%). UMB also plans to expand undergraduate enrollment by 13% with virtually all of the increase at the Universities at Shady Grove. Conversely, the projected growth for Towson, Salisbury and UMBC is expected to lean towards the graduate level but with growth at the undergraduate level as well (between 13% and 17% overall). UMCP has, with these projections, reversed its previous plan to reduce enrollment with a projection for an increase of over 7%. Frostburg is projecting very little growth (2.5%) (see Tables 5 through 15).
- In terms of headcount change, UMUC remains the largest driver of headcount growth, planning to add the most students – more than 18,000 by 2020. Towson is second with plans to add 3,400 students. Five additional institutions (Bowie, UB, UMBC, UMCP and UMES) plan to add between 1,800 and 2,500 students. As a group, the HBCUs plan to add around 5,000 students, while the other comprehensive institutions more than 5,700. The research institutions will add nearly 5,600, which is by far the most significant planned increase in their enrollment in the past decade (see Tables 5 through 15).
