SUMMARY: This report provides information on the status of capital improvement projects systemwide. Included are contract awards, completions, and detailed project schedules. The attached report reflects activity for the eight month period ending August 31, 2011. Highlights include:

- Four design awards (\$10.1 million)
 - Three design awards to Maryland firms (\$8.8 million)
- Twenty-one construction awards (\$100.6 million)
 - Seventeen construction awards to Maryland firms (\$97.5 million)
- Twenty-seven project completions (\$572.1 million)

PROGRESS OF CAPITAL IMPROVEMENT PROJECTS (For the period ending August 31, 2011)

This report provides information on capital projects systemwide, excluding energy performance contracts. Projects are funded through a variety of sources: State capital and operating funds, including facilities renewal; internal funding through the System Funded Construction Program (SFCP); private funds; and federal grants. This report is a summary of contract awards, project completions and project schedules for the eight month period ending August 31, 2011. Only large facilities renewal projects are included in this report.

ONGOING PROJECTS:

As of August 31, 2011, there are a total of 38 projects systemwide in design or construction that are managed by the service centers.

CONTRACT AWARDS:

a. Design Awards

Four design contracts in the amount of \$10.1 million were awarded during the eight-month period ending August 31, 2011. All but \$1.3 million was awarded to Maryland firms.
