## Summary of New Companies Facilitated by USM Institutions by Tier

#### Tier 1: 7 total

- UMCP 5 licensed university-owned IP
- UMB 1 licensed university-owned IP
- UMBC 1 licensed university-owned IP

### Tier 2: 19 total

- UMCP 4 received significant mentoring from the Mtech Venture Accelerator
   Program and were members of the Terp Startup Lab
- UMBC 4 received significant business mentoring from bwtech@UMBC, of which 3 were recruited from out-of-state
- UMB 1 was recruited from out-of-state to UMB's Bio Park
- UMES 1 received a significant loan from UMES's Revolving Loan Fund
- SBDCs 9 received significant mentoring (UB 2; UMCP 3; Salisbury 4)

## Tier 3: 89 total

- UMCP 20 moved into and received counseling services from the EnTERPreneur Academy Incubator
- UMCP 40 received investments or counseling through the Dingman Center
- UMCP 3 won the "Be the Solution" Business Plan Competition
- Towson 1 won a Business Plan Competition and moved into the Towson Incubator
- SBDCs 25 received counseling services from the SBDCs


### Tier 4: 13 total

# University System of Maryland New Company Formation


