**TOPIC**: Report on the Teacher Education Summit

**COMMITTEE**: Education Policy and Student Life

**DATE OF COMMITTEE MEETING:** November 20, 2013

<u>SUMMARY</u>: On October 11, 2013, a group of Maryland's P-20 education partners sponsored a Teacher Education Summit at Towson University. The objective of the Summit was *to conduct a comprehensive review of the major issues and components of teacher education in Maryland in order to identify common challenges, themes, priorities to meet the changing needs of students and society.* The sponsoring partners included the University System of Maryland, Maryland State Department of Education, Maryland Higher Education Commission, Maryland Association of Community Colleges, and Maryland Independent College and University Association. The event also received support from the Lumina Foundation and College Readiness Partnership, which includes American Association of State Colleges and Universities, Council of Chief State School Officers and State Higher Education Officers Association.

Participants included 235 educators from all segments: K-12 teachers, principals, superintendents, higher education deans and directors of teacher education, arts and sciences faculty and deans, and policy leaders from across the state. The keynote presenter, State University of New York Chancellor, Nancy Zimpher, offered a vision for teacher preparation that challenged many assumptions, proposing to "turn teacher preparation upside down."

Ninety-two percent of attendees responding to the evaluation agreed that the Summit was and that similar gatherings would be critical to moving teacher preparation forward. Discussions surrounded the changing role of teachers, technology knowledge and skills, indicators of teacher preparation program quality, and partnership and collaboration. In response to work conducted during the Summit, the Governor's P-20 Leadership Council plans to charge a Task Force on Teacher Education to develop a set of recommendations regarding teacher education in Maryland higher education institutions, including: (a) policy and regulations, (b) curriculum and instruction, (c) induction and internship, and (d) resource allocations in order to advance the quality of teacher education programs in Maryland.

## Charge to the Governor's P-20 Leadership Council

## Task Force on Teacher Education

**Background**: At the recent Teacher Education Summit (October 11, 2013, Towson University), 235 educators and policy leaders addressed important issues emerging around teacher preparation and teacher professional development. These issues can and should be addressed by the Governor's P-20 Leadership Council as part of the broader education and workforce agenda. Illustrative issues include:

- 1. Significant changes for teachers related to content and disciplinary background knowledge and pedagogy necessary to teach the Common Core State Standards and prepare students for the PARCC (Partnership for Assessment of Readiness for College and Careers) assessments, and Next Generation Science Standards (NGSS)
- 2. New program accreditation and teacher evaluation standards (Council for the Accreditation of Educator Preparation and Maryland's State-wide Educator Evaluation System)
- 3. New programs being offered by non-traditional providers (for-profits, Teach for America) to both traditional and non-traditional students
- 4. Realignment of the community college Associate of Arts in Teaching (AAT) pathways

**Proposal**: Establish a Task Force on Teacher Education, building on the outcomes and positive energy from the October 11, Teacher Education Summit.

**Charge:** The P-20 Task Force on Teacher Education is charged with making recommendations and creating an action plan that will ensure high quality teacher education programs that are responsive to the needs of the K-12 schools, aligned with the Common Core State Standards, and designed to support student success for all Maryland students. Specifically the Task Force will:

- Examine Maryland policies and regulations on teacher education in the context of the new Common Core State Standards and Next Generation Science Standards to identify gaps and alignment needs;
- Building on the outcomes of the October 11 Teacher Education Summit, review pertinent research on global best practices in teacher education;
- Make recommendations to the Governor's P-20 Leadership Council for appropriate changes in (a) policy and regulations, (b) curriculum and instruction, (c) induction and internship programs, and (d) resource allocations in order to advance the quality of teacher education programs at Maryland's higher education institutions.

**Timeline:** The Task Force will submit its preliminary report to the P-20 Workgroup by February 15 for review and to the P-20 Leadership Council by March 1.

### KEYNOTE SPEAKER

Nancy Zimpher is the 12th Chancellor of the State University of New York (SUNY). Prior to this appointment, Zimpher served as president of the University of Cincinnati, chancellor of the University of Wisconsin-Milwaukee, and executive dean of the Professional Colleges and dean of the College of Education at The Ohio State University. She is nationally recognized in the areas of teacher preparation, urban education, and university-community engagement. As co-founder of Strive, Zimpher has been instrumental in creating a national network of innovative systemic partnerships that holistically address challenges across the education pipeline. She is board chair of both the New York Academy of Sciences and CEOs for Cities. She also led the national Coalition of Urban Serving Universities and co-chaired NCATE's blue-ribbon panel on transforming teacher preparation. Zimpher holds a bachelor's degree in English education and speech, a master's degree in English literature, and a Ph.D. in teacher education and higher education administration, all from The Ohio State University.

## **PANELISTS**

David W. Andrews, a distinguished scholar who has dedicated his career to improving academic and behavioral outcomes for at-risk children and youth, was appointed dean of The Johns Hopkins University School of Education in 2010. Andrews was the founding dean of The Ohio State University's College of Education and Human Ecology. Prior to joining Ohio State, he held positions at Oregon State University and the University of Oregon. Andrews earned his bachelor's degree in psychology from Auburn University, as well as a master's degree from Kansas State University and a doctorate from Florida State University, both in child development.

Denny Gulick is a professor of mathematics at the University of Maryland, College Park, where he has been heavily involved in issues related to teaching. Gulick served on the "reading group" for the new Common Core State Standards (CCSS) in Mathematics and has worked with PARCC to develop assessments for the CCSS. He received his bachelor's degree from Oberlin College and his master's degree and Ph.D. in mathematics from Yale University. He was an instructor for two years at the University of Pennsylvania before coming to Maryland.

Rhonda Holmes-Blankenship, a national board certified teacher, teaches 10th and 11th grade English at Rising Sun High School in Cecil County. Holmes-Blankenship was named the 2012-13 Maryland Teacher of the Year and was one of four finalists for the 2013 National Teacher of the Year award. She graduated from Towson University in 1995 with a B.S. in English and received an M.S. in curriculum and instruction from McDaniel College in 2005.

**Deborah Poese** has been a member of the faculty of Montgomery College (MC) since 1984. Poese has also served at MC as chair of the Department of Mathematics and interim instructional dean for science, engineering and mathematics. Since 2007, she has been the director of the School of Education at MC. Poese holds degrees in mathematics and education from Truman State University (formerly Northeast Missouri State University), as well as a master's degree in mathematics from the University of Maryland, College Park.


James Takona was named dean of the College of Arts and Sciences and Education at Coppin State University (CSU) in July 2013. Previously, Takona was dean of the School of Education at CSU. Prior to coming to CSU, Takona was associate dean of the College of Education at Spalding University in Louisville, Ky. Born and raised in Kenya, East Africa, he earned his Ph.D. in curriculum and instruction with a concentration in higher education and program evaluation from Loyola University of Chicago.

Henry Wagner was appointed superintendent of Dorchester County Public Schools in 2010. Previously, Wagner served as assistant superintendent for instruction. He worked in the Baltimore County Public Schools for 22 years as a teacher, school counselor, high school assistant principal, and as principal of two middle schools. Wagner then served as a principal, and later as director of secondary education, in Wicomico County Public Schools. Wagner earned a bachelor's degree in history and secondary education from Loyola University, two master's degrees from Johns Hopkins University, and a Doctor of Education at Wilmington University.
