STATUTORY AUTHORITY TO CLOSE A SESSION State Government Article §10-508(a):

	[]	(i) The appointment, employment, assignment, promotion, discipline, demotion, compensation, removal, resignation, or performance evaluation of appointees, employees, or officials over whom it has jurisdiction; or
	[X]	(ii) Any other personnel matter that affects one or more specific individuals.
(2)	[X]	To protect the privacy or reputation of individuals with respect to a matter that is not related to public business.
(3)	[X]	To consider the acquisition of real property for a public purpose and matters directly related thereto.
(4)	[]	To consider a preliminary matter that concerns the proposal for a business or industrial organization to locate, expand, or remain in the State.
(5)	[]	To consider the investment of public funds.

To prepare, administer or grade a scholastic, licensing, or qualifying (11)examination. (12)To conduct or discuss an investigative proceeding on actual or possible [] criminal conduct. (13)To comply with a specific constitutional, statutory, or judicially imposed [] requirement that prevents public disclosures about a particular proceeding or matter. (14)[X] Before a contract is awarded or bids are opened, to discuss a matter directly related to a negotiation strategy or the contents of a bid or proposal, if public discussion or disclosure would adversely impact the ability of the public body to participate in the competitive bidding or proposal process.

TOPICS TO BE DISCUSSED: Institutional administrative and budgetary matters; BOR procedural matters; nominees for the awarding of honorary degrees at BSU, TU, UB, UMB, UMBC, UMUC; BOR faculty awards; Regents' Entrepreneur of the Year award; collective bargaining matters; potential legislation and strategic budgetary matters pertaining to the 2013 General Assembly; mid-year evaluation of USM presidents; review of a faculty termination appeal; Institutional real property transactions in the City of Baltimore; a renewable energy contract that has not yet been awarded; a potential contract and acquisition for UMCP; naming of a building at UMBC; briefing on open meetings act complaint; potential litigation and other legal matters; and compensation issues.
