Minutes of Closed Session April 12, 2013 University of Baltimore

At the conclusion of the public meeting of the USM Board of Regents held on Friday, April 12, 2013 at the University of Baltimore in the Hilda and Michael Bogomolny Room of the Student Center, Chairman Shea called for a vote to reconvene in closed session citing State Government Article Subtitle 5, Section §10-508(a) of the Open Meetings Act to discuss issues specifically exempted in the Act from the requirement for public consideration. Chairman Shea read the items to be discussed in the closed session. (A copy of the statement is attached.) - 8. The regents were briefed on a litigation matter and other legal matters.
- 9. The regents approved a collective bargaining MOU for Towson University and discussed collective bargaining issues at University of Maryland, Baltimore and Coppin State University.
