As required by law, the vote on the closing of the session will be recorded. ## STATEMENT REGARDING CLOSING A MEETING OF THE USM BOARD OF REGENTS

## STATUTORY AUTHORITY TO CLOSE A SESSION State Government Article §10-508(a):

- (1) To discuss:
  - [X] (i) The appointment, employment, assignment, promotion, discipline, demotion, compensation, removal, resignation, or performance evaluation of appointees, employees, or officials over whom it has jurisdiction; or
  - [] (ii) Any other personnel matter that affects one or more specific individuals.
- (2) [X] To protect the privacy or reputation of individuals with respect to a matter that is not related to public business.
- (3) [X] To consider the acquisition of real property for a public purpose and matters directly related thereto.
- (4) [] To consider a preliminary matter that concerns the proposal for a business or industrial organization to locate, expand, or remain in the State.
- (5) [X] To consider the investment of public funds.
- (6) [] To consider the marketing of public securities.
- (7) [X] To consult with counsel to obtain legal advice on a legal matter.
- (8) [] To consult with staff, consultants, or other individuals about pending or potential litigation.
- (9) [X] To conduct collective bargaining negotiations or consider matters that relate to the negotiations.

- (10) [] To discuss public security, if the public body determines that public discussions would constitute a risk to the public or public security, including:
  - (i) the deployment of fire and police services and staff; and
  - (ii) the development and implementation of emergency plans.
- (11) [] To prepare, administer or grade a scholastic, licensing, or qualifying examination.
- (12) [] To conduct or discuss an investigative proceeding on actual or possible criminal conduct.
- (13) [] To comply with a specific constitutional, statutory, or judicially imposed requirement that prevents public disclosures about a particular proceeding or matter.
- (14) [X] Before a contract is awarded or bids are opened, to discuss a matter directly related to a negotiation strategy or the contents of a bid or proposal, if public discussion or disclosure would adversely impact the ability of the public body to participate in the competitive bidding or proposal process.
  - [X] Administrative Matters

TOPICS TO BE DISCUSSED: Meeting with Presidents Gibralter and Miyares as part of their performance evaluation; approval of an honorary degree request from the University of Baltimore; review of an employment contract under BOR policy VII-10.0; a compensation issue for a USM president; review of two collective bargaining MOUs for Coppin State University and a briefing on matters that relate to collective bargaining negotiations; the appointment of officials to the UMBC Research Park Board, the acquisition of real property in Riverdale Park; before a contract(s) for audio visual equipment is awarded, discuss matters directly related to the contents of the bid(s) or proposal(s); initial budget document preparation; potential investment in capital renovations for proposed UMD-Corcoran partnership; and legal advice regarding the above matters.

## REASON FOR CLOSING:

To review and discuss items permitted to be discussed in closed session by §10-508 and to carry out administrative functions.
