SUMMARY: This report provides information on the status of capital improvement projects systemwide. Included are contract awards, completions, and detailed project schedules. The attached report reflects activity for the six-month period starting February 1, 2013 and ending July 31, 2013. Highlights include:

- > Two design awards to Maryland firms (\$1.3 million)
- > Nineteen construction awards to Maryland firms (\$158.3 million)
- Seven project completions (\$249.7 million)

PROGRESS OF CAPITAL IMPROVEMENT PROJECTS (For the period ending July 31, 2013)

This report provides information on capital projects systemwide, excluding energy performance contracts. Projects are funded through a variety of sources: State capital and operating funds, including facilities renewal; internal funding through the System Funded Construction Program (SFCP); private funds; and federal grants. This report is a summary of contract awards, project completions and project schedules for the six-month period beginning February 1, 2013 and ending July 31, 2013. Only construction projects that are \$1 million, or greater, are included in this report.

ONGOING PROJECTS:

As of July 31, 2013, there are a total of 49 projects systemwide in design or construction that are managed by the service centers.

CONTRACT AWARDS:

a. Design Awards

Five design contracts in the amount of \$8.6 million were awarded during the six-month period ending July 31, 2013.
