The open session of today's meeting will be adjourned following completion of the regular public agenda, and the Committee will reconvene in closed session to discuss issues specifically exempted in the Act from the requirement for public consideration. As required by law, the vote on the closing of the session will be recorded. In addition, a written statement of the reason for closing the meeting at this time, including a citation of the authority under §10-508(a) and the topics include: review of an employment contract under policy VII-10.0; a compensation issue for a USM president; review of two collective bargaining MOUs and one MOU in negotiation; and an update on labor relations issues.
