TOPIC: New Program 5-Year Enrollment Review

COMMITTEE: Education Policy and Student Life

DATE OF COMMITTEE MEETING: January 14, 2014

<u>SUMMARY</u>: As part of the program review process, the attached data has been added to provide the Committee with information regarding the actual enrollments in new programs approved since 2011. The data reflects the relative accuracy in the projected enrollments that are included in all new program proposals. Six-year graduation data will be included in the 2017 report. With this new data set and the periodic review report, the Board will have a more complete picture of the life cycle of a program, from the time of implementation through the first graduating cohort and the seven-year periodic reviews.

It is important to note that not all programs are implemented in the year that it is approved. Dependent upon the date of Board and MHEC approval, recruitment and admission to the program may not begin until the following year and therefore no enrollments are reported. In other cases, admission to the program may not occur until the students have completed the required core courses, examinations, etc. and so enrollments would be reported two years after implementation. For example, admission to teacher education programs require two years of prerequisite courses, satisfactory test scores, and a competitive grade point average.
