- Sixteen construction awards to Maryland firms (\$36.4 million)
- Four project completions (\$174.7 million)

PROGRESS OF CAPITAL IMPROVEMENT PROJECTS (For the period ending July 31, 2014)

This report provides information on capital projects systemwide, excluding energy performance contracts. Projects are funded through a variety of sources: State capital and operating funds, including facilities renewal; internal funding through the System Funded Construction Program (SFCP); private funds; and federal grants. This report is a summary of contract awards, project completions and project schedules for the six-month period beginning February 1, 2014 and ending July 31, 2014. Only construction projects that are \$1 million, or greater, are included in this report.

ONGOING PROJECTS:

As of July 31, 2014, there are a total of 45 projects systemwide in design or construction that are managed by the service centers.

Seven design contracts in the amount of \$23.6 million were awarded during the six-month period ending July 31, 2014.
