SUMMARY: The attached chart summarizes the status of each of the USM's collective bargaining agreements and/or negotiations, as of the end of calendar 2013. The USM has 26 bargaining units, including 11 for non-exempt employees, 5 for exempt employees and 10 for sworn police officers. Currently, there are 18 active MOUs across the USM.
