



TOPIC: Results of New Program 5-Year Enrollment Review

COMMITTEE: Education Policy and Student Life

DATE OF COMMITTEE MEETING: January 13, 2015

SUMMARY: As part of the ongoing program review process, the attached data has been updated with Fall 2014 enrollments to provide the Committee with information regarding the actual enrollments in new programs approved since FY 2011. The fall enrollment data reflect the relative accuracy in the projected enrollments that are included in all new program proposals. All *actual* enrollments are the students' primary major as reported in the MHEC Enrollment Information System files. Administrative coding changes may lag actual program demand in initial years. Six-year graduation data will be included in the 2017 report.

It is important to note that not all programs are implemented in the year it is approved. Dependent upon the date of Board and MHEC approval, recruitment and admission to the program may not begin until the following year and therefore no enrollments are reported. In other cases, admission to the program may not occur until the students have completed the required core courses, examinations, etc. Subsequently, enrollments would be reported two years after implementation. For example, admission to teacher education programs requires two years of prerequisite courses, satisfactory test scores, and a competitive grade point average.
