Warm wishes as we start the spring from the Council of University System Staff (CUSS).

The council conducted its last meeting on March 26 at the Maryland State House as part of our USM Staff Advocacy Day. As part of the day, the Council was briefed by Assistant Vice Chancellor Andy Clark about the latest legislation and activities impacting the USM.

Delegate Clarence Lam was invited to address the council. Delegate Lam is an alumnus of UMB and was a past President of the University Student Government Association. He provided the council how shared governance has shaped his lens of governance and how this is has impacted his freshman year in Annapolis. In addition, he expressed his support for higher education, the USM, and our staff.

Following the initial meeting, the council was recognized in both chambers of the assembly. After the recognition, the council was able to remain as the Senate had the third reading of the State Budget and BRFA bills.

Finally, the council went and visited all the offices of our delegates and senators. A letter (see attached) and the council newsletter were provided. Overall the council reached 96% of the delegates and 97% of the senators with multiple one on one conversation.
