SUMMARY: In accordance with Board Resolution III-7.03, a report is submitted annually to the Board of Regents of program actions delegated to the Chancellor. Between September 2014 and August 2015, former Chancellor Brit Kirwan approved 27 new certificates and concentrations and 10 title changes. He also approved the suspension of 2 degrees and 3 areas of concentration. In addition, the Board of Regents approved 16 new degree programs.
