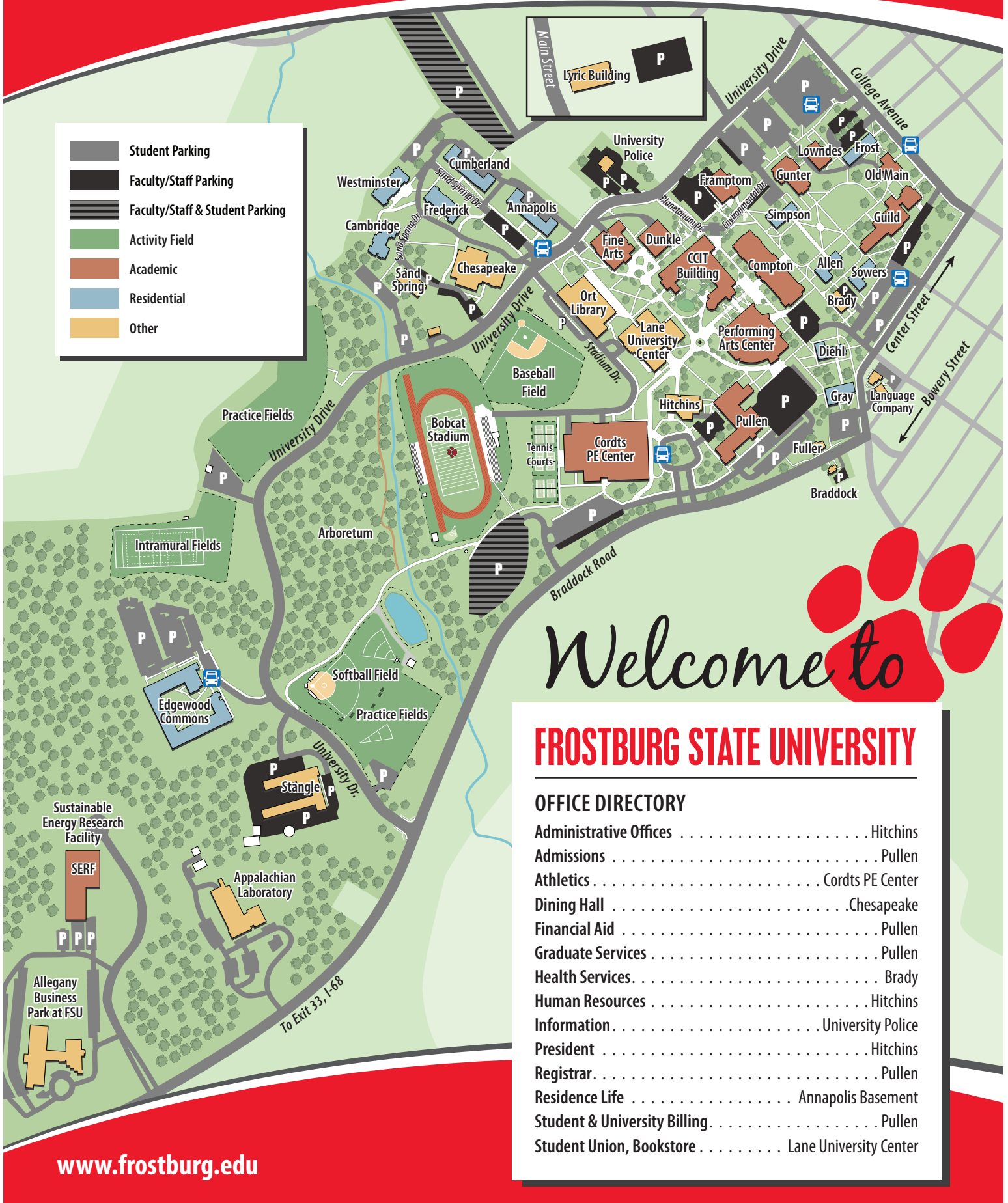
Demand Study: Complete 10/19/15

Supply-induced demand if the University creates a new facility comprised of the type of units preferred by survey respondents (quality, configuration, cost)	400 Beds
Added demand if a new policy requiring Freshman and Sophomores to live on campus (with certain exceptions) is implemented	350 Beds
Total New Demand	750 Beds
Less current vacancies*	-146 Beds*
Net Total Demand (with these conditions) for new facility	604 Beds
Desired size of new facility	425 Beds

*96 of these beds have been deliberately taken offline by the campus for renovation or to provide private rooms for certain students (e.g., Resident Assistants)

Notes:

- Largest overall enrollment in 117-year history
- Undergraduate enrollment has grown by 15% over the past decade from 4,321 in 2005
- Number of international students has grown to a record level of 116 students
 - ✓ 80 additional applications for degree-seeking international students for spring 2016
- Newest residence hall was built in 1976 creating challenges for recruitment not only from the age of the buildings—the configurations are not what current students request
 - ✓ 5 small traditional residence halls have been renovated since 2008
- Edgewood Commons (Public-Private-Partnership) has been filled for the past three years and is now generating ground rent
- A new FSU residence hall will generate an additional \$1.8M of revenue from meal plans
 - ✓ FSU does not have any debt on its residence halls
