



TOPIC: University System of Maryland: Report on FY 2015 Procurement Contracts

COMMITTEE: Finance

DATE OF MEETING: January 28, 2016

SUMMARY: The USM Policy on Approval of Procurement Contracts requires that procurement contracts of \$1 million to \$5 million, and emergency and expedited procurement contracts of \$5 million or more, shall be reported to the Committee on Finance.

Attached is the report of the procurement contracts awarded during Fiscal Year 2015 (July 1, 2014 - June 30, 2015). As provided in the policy, the report does not include construction contracts for capital projects approved by the Board of Regents, sponsored research/education contracts and grants, and contracts pertaining to interests in real property.

Twenty-six contracts have been awarded that meet the reporting requirements totaling \$56.1 million. There were not any emergency or expedited procurement contracts of \$5 million or more during the reporting period. 38.5% of the total dollars awarded were awarded to Maryland firms. The MBE participation on the contract awards was 26%.
