Her presentation included highlighting new awards of distinction, including UMBC's new Lunar Environment Monitoring Station, Coppin State University's Professor Lori Harvin's selection as Business



Higher Education Forum Innovation Fellow, the NSF Convergence Accelerator Award to UMCES' Ming Li, a Sloan Research Fellowship awarded to UMD's Sasha Philipov, and the Greater Baltimore Committee Tech Hub resource application. She also opened the floor the guest speaker Jerry Waldron, who presented on MDREN and the many cyber security and IT services it provides the USM, and to Edo Waks and Bala Balachandran, who presented on their respective research projects, and the ways in which receiving a Multidisciplinary University Research Initiative (MURI) Award from the Department of Defense has benefited them. 3. Momentum Fund Update. Mike Ravenscroft introduced Minnowtech and its CEO Ken Malone, who gave a presentation on Minnowtech. The presentation covered the history of the company, its aims and products, and the beneficial impact the Momentum Fund has had on them.
