Topic Prior minutes Executive Committee meetings for January 6, 2019	Discussion Motion provided and seconded.	Actions Approved; pending in edits.
USM update report from Joann Boughman and Chair's report from Robert Kauffman	Report provided by both Joann Boughman and Robert Kauffman	
Upcoming Legislative Budget	Discussion took place regarding the legislative session. One item is an approximately \$10 million dollar cut from workforce development.	
Enrollments	To increase enrollments, all should consider more focus on college students with no degrees completed (sometimes called "near completers") as an untapped source. The USM/MD articulation system (ARTSYS) needs to be enhanced to be most effective in ensuring students transfer successfully into four-year institutions. Joann indicated that work is taking place with the Provosts and others as to the cost to do so. The figure of \$5 to \$10 thousand a year per campus has been presented. This will be addressed centrally as well. Those that work as transfer coordinators are needed to figure out

	Elizabeth Brunn asked if enrollments would be an ideal topic for discussion with the Senate Chairs.	It was concluded that it is a good discussion topic.
Shared Governance	Robert Kauffman indicated that the Shared Governance survey was sent out and will probably sent out again. Robert confirmed that the Chancellor plans to attend CUSF meetings quarterly.	
Advocacy Day	Robert Kauffman sent an Advocacy Day announcement to CUSF. To date, there have been 18 responses, although he was not sure if the 18 were attending or just responses. [Note: It was responses. Roughly, ten faculty members attended.]	Robert will check further to determine whether all 18 responded in the affirmative or not.
In memoriam recognition	Joann Boughman asked the Ex Com if they would be in favor of honoring a Coppin faculty member who passed during the upcoming Regents Awards Ceremony. Dr. Katherine Cameron made many outstanding contributions to the university and USM and is deserving of recognition. Her recognition would not be connected to the awards that are given to the faculty who will be Regents Awards winners, but it makes sense to recognize her during that ceremony.	A motion to this effect was made and passed unanimously by ExCom.
Incivility/Academic Integrity	Robert Kauffman raised the topic of incivility to the committee (which also includes academic integrity). He noted that it is important to the Chancellor and Presidents and that it needs to be further developed before moving forward. He suggested we should consider engaging the USM Student Council in this topic as well. Joann Boughman noted that some ideas of civility include issues surrounding students, faith, and freedom of speech, which is present	With the in-depth work necessary to move forward, Elizabeth Brunn plans to resubmit integrity policy work to CUSF. First, however, Zakiya will give Elizabeth comments Zakiya, MJ, and Joann have on the policy development and revisions. Karen Clark sent a Word docx copy to Zakiya Lee; Zakiya will edit and share with Elizabeth.

	Elizabeth Brunn posed the topic of what are available resources to address academic integrity violations within USM. Karen Clark mentioned the connection of this conversation to respect and how respect of others is also part of interprofessional education and interdisciplinary engagement among everyone, students, staff, and faculty and that faculty need to demonstrate this behavior as expected behavior.	With the in-depth work necessary to move forward. Elizabeth Brunn planned to resubmit to CUSF her work on the integrity polices. First however, Zakiya Lee will review the work completed by Elizabeth to determine (with Joann) how to consolidate the work for more clarity. Karen Clark sent a Word docx copy of it to Zakiya Lee so she can use the track changes option in Word while working on the document.
	Robert Kauffman suggested that a rationale be added to each section, perhaps in a text box, to explain to the reader why the recommended change is being made. This helps to make the proposed changes fully transparent	
Further for the Chair's Report	Robert Kauffman indicated we need to continue to work (see discussion above) on academic integrity.	
	Emeritus Faculty as a board member resolution and commentary have been submitted, and we are awaiting feedback.
