12:37 USM Update: Joann (Note: There was no June Chancellor's Council) Jo spoke to the following points:

- Return to campus Most campuses will return with some students.
- It will involve a face-to-face and online presence.
- All schools are prepared to have a temperature, symptom questioning, and contact tracing regime in place.
- Testing is being piloted with athletes and staff this summer to hopefully find answers to major questions remain as to legal concerns, availability, professional application and effective implementation if COVID 19 is discovered among students.
- Some campuses starting early and ending early others will remain online only with few exceptions for research and STEM/labs.
- Faculty, staff and students who feel compromised by returning will likely be accommodated as best the school can.
- The need for everyone parents, students, faculty, and staff to work together as a community is extremely important, hence the need for faculty in their advisory capacity will be called upon to help promote the overall needs of the community in a civic capacity.
