



TOPIC: University System of Maryland: Report on FY 2011-12 Procurement Contracts

COMMITTEE: Finance

DATE OF MEETING: November 15, 2012

SUMMARY: The Board of Regents approved the USM Policy on Approval of Contracts on October 19, 1989. The policy provides that procurement contracts of \$1 million to \$5 million, and emergency and expedited procurement contracts of \$5 million or more, shall be reported to the Committee on Finance.

Attached is the report of the procurement contracts awarded during Fiscal Year 2011 and 2012 (July 1, 2010 - June 30, 2012). As provided in the policy, the report does not include construction contracts for capital projects approved by the Board of Regents, except for those that exceed the approved amount by more than 20 percent, sponsored research/education contracts and grants, and contracts pertaining to interests in real property.

Fifty-two contracts have been awarded that meet the reporting requirements. There were not any emergency or expedited procurement contracts of \$5 million or more during the reporting period. Fifty-six percent of the total dollars awarded were awarded to Maryland firms. For the sum of those contracts awarded meeting the reporting criteria MBE participation was 18%.
