STATUTORY AUTHORITY TO CLOSE A SESSION

Md. Code, General Provisions Article §3-305(b):

MHEC; advice from counsel regarding conflict of interest issues; discussion of communication and other strategies relating to potential legislation; discussion regarding process of updating BOR on ongoing campus renovation project; legal advice on open meetings law requirements and discussion of new USM personnel appointment.

proposed collective bargaining agreement prior to approval (§3-305(b)(9)); to maintain confidentiality of ongoing collective bargaining negotiations between institutions and unions (§3-305(b)(9)); to maintain confidentiality of personnel information of presidents (§3-305(b)(1)(i)); to protect the personnel-related information and privacy of individuals who have been recommended for Regents' Faculty Awards or nominated for an honorary degree (§3-305(b)(1) and (2)); to maintain confidentiality of ongoing legislative audit matters as required by law (§3-305(b)(13)); to maintain confidentiality of investigative matters which may lead to criminal prosecution (§3-305(b)(12)); to maintain confidentiality of discussion of ongoing litigation (§3-305(b)(8)); to maintain attorney client communication privilege (§3-305(b)(7)); and to maintain confidentiality of personnel-related information of appointee (3-305(b)(1)(i))
