Minutes of the Closed Session

- 1. University of Maryland Center for Environmental Science Ratification of MOU with MCEA covering nonexempt staff. The Regents recommended ratification of the MOU between University of Maryland Center for Environmental Science and MCEA covering nonexempt staff. (§3-305(b)(9)).
- 2. University System of Maryland Pre-Negotiation Briefing re Consolidated MOU with AFSCME covering nonexempt staff, exempt staff, and sworn police. The Regents recommended ratification of the MOU between the University of Maryland, College Park and the FOP covering police. (§3-305(b)(9)).
- **3.** Collective Bargaining Update. The Regents were provided with the status of collective bargaining negotiations at each USM institution. (§3-305(b)(9)).
- **4.** Committee on Governance and Compensation Workplan. The Regents discussed an administrative matter concerning the committee workplan. (§3-103(a)(1)(i)).
- **5.** Update on Multi-Year Presidential Reviews. The Regents discussed multi-year reviews of presidents. (§3-305(b)(1) and §3-103(a)(1)(i)).
- **6. Update from the Chancellor on TU Search.** The Chancellor provided an update on the TU president search, including discussion of an interim president. (§3-305(b)(1) and §3-103(a)(1)(i)).
- 7. Employee Deferred Compensation Options. The Regents received legal advice concerning employee deferred compensation options. (§3-305(b)(1) and §3-305(b)(7)).
- **8. Review of Certain Contracts and Employment Agreements.** The Regents reviewed personnel contracts from TU, UMCP, and the USM subject to review under Policy VII-10.0 (§3-305(b)(1)).

Board of Regents Committee on Economic Development and Technology Commercialization December 7, 2022

Charge:

The Committee on Economic Development and Technology Commercialization shall provide strategic leadership for the USM's research, economic development, technology commercialization, innovation, and entrepreneurial initiatives, programs, and policies.

Role and Responsibilities:

The Committee on Economic Development and Technology Commercialization shall consider and report or recommend to the Board of Regents on matters concerning economic development and technology commercialization, innovation and entrepreneurial initiatives, and research, including translational research and technology transfer.

Members of the Committee on Economic Development and Technology Commercialization are appointed annually by the Chairperson of the Board. The Committee shall meet as needed, but no fewer than four times during the fiscal year.

Created in July 2011 in recognition of the increasing importance of translational research, entrepreneurship and innovation, and the supply of skilled workers in STEM fields for the State of Maryland, the Committee, working with the Vice Chancellor for Research and Economic Development, may expect to receive information for review in order to consider, and/or act on any of the following matters:

- A. Aligning resources with market demand
- B. Leveraging USM resources through collaborations
- C. Enhancing partnerships with industry, state, and federal entities
- D. Strengthening the USM Research and Innovation ecosystem, including engaging with research funding and commercialization partners, enhancing research administration and compliance infrastructure, and fostering excellence in scholarship, research, creative, and innovation
- E. Strengthening the USM entrepreneurial ecosystem, including engaging the investment community and enhance access to capital for USM affiliated startups and innovators

In that event, the Board would reconvene in open session to discuss the open session topic or to vote to reconvene in closed session to discuss the additional closed session topic.
