## REGENTS REPORT

### **Greetings from the Board of Regents**

We write to you at the close of Maryland's 2023 legislative session. It was an extremely busy one, with scores of bills affecting the University System and the students we serve. It was also a productive one, and we thank all those who skillfully steered us through several hectic months.

Of course, we're fortunate to enjoy a relationship with our elected leaders that's close and mutually beneficial: For the state's generous support of our tri-part mission in education, research, and service, we work every day



to make Maryland stronger, more prosperous, more equitable, and more just.

These goals were advanced by an operating budget that allows us to limit our tuition increase for instate undergraduates. The budget funds Year 2 of enhanced investment in our historically Black institutions. It supports new facilities that expand our academic and research capacity. And it covers pay raises and climbing benefits costs for our employees, helping us attract and retain the very people who drive our excellence. Our capital budget supports construction and renovation projects across the state, creating spaces that don't just *house* our work in education and discovery, but that nurture and enrich it, enabling it to grow.

As always, we saw a significant number of bills that affect the System and our people. But there are two in particular whose passage we celebrate. Senate Bill 426 authorizes the Board of Regents to establish a quasi-endowment fund of up to \$150 million, generating income to support financial aid for our students. This is just one way we're serving students in need—doing our part to ensure not only that they can access a USM education, but that they can stay in school until they have their diploma in hand.

Senate Bill 142 authorizes the Board to award a grant, supported by private donors, to our first-year student regents. We believe that acknowledging in this way the significant sacrifice of time and effort made by our student regents will attract others interested in this important act of leadership and service.

We're grateful to all of Maryland's elected leaders for their commitment to the University System and the work we do. Certainly, we're grateful for their abiding faith in our students and their boldest ambitions.

### **Board Actions & Decisions | April 14, 2023**

The USM Board of Regents met at Coppin State University on April 14, 2023, with public viewing available in-person and via <u>livestream</u>. At this meeting, key actions by the Board included:

Presentation of the 2023 USM Regents Faculty Awards. Prior to the Board of Regents meeting, the USM held a special breakfast to honor the winners of the 2023 USM Regents Faculty Awards. Nominated by their institutions, the 19 award winners were selected based on their extraordinary contributions in one of the following categories: Teaching; Mentoring; Public Service; Scholarship or Research; or Creative Activity. These exemplary faculty members represent nine different USM institutions and an incredibly diverse range of academic disciplines and research interests. Board Chair Linda Gooden and Chancellor Jay Perman presented each winner with a a commemorative plaque and a \$2,000 prize.

Approval of the Fiscal Year 2024 Schedule of Tuition and Mandatory Fees. Each year, the presidents of USM institutions can recommend tuition and fees adjustments for the upcoming academic year, which are then subject to the review and approval of the Board of Regents. The Finance Committee shared the <u>proposed rates for tuition and fees for FY 2024</u>, which were approved by the regents. Across the system, in-state undergraduate full-time and part-time tuition rates will not increase by

more than 2 percent and out-of-state undergraduate rates will not increase by more than 5 percent. Graduate full-time and part-time tuition rates will not increase above 5.3 percent, with increases at most institutions below 5 percent. In addition, the Board approved <u>increases to room, board, and parking rates</u> at several institutions to address the rising cost of goods and services.

**Eastern Shore.** While approving the presidents' proposed tuition rates for FY 2024, the Board simultaneously approved a <u>joint proposal</u> by Coppin State University and University of Maryland Eastern Shore to offer in-state tuition rates to out-of-state students who reside in a state or region without an HBCU (Historically Black College and University). This plan will help these two USM universities expand their geographical enrollment footprint, increase successful recruitment of out-of-state students, and bolster relationships with states in which a student-transfer agreement is in place.

Approval of Five New Academic Programs. After reviewing the recommendations of the Committee on Education Policy and Student Life, the board approved the following new undergraduate and graduate academic programs, which will be offered pending the approval of the Maryland Higher Education Commission.

- Bachelor of Science, Environmental Science, Frostburg State University
- Master of Science, Counseling Psychology, University of Baltimore
- Master of Science, Industrial and Organizational Psychology, University of Baltimore
- Doctor of Philosophy (Ph.D.), <u>Autism Studies</u>, Towson University
- Doctor of Philosophy (Ph.D.), Business Analytics, Towson University

Approval of the University of Maryland, Baltimore (UMB) Facilities Master Plan Update. The Board approved the UMB 2022 Facilities Master Plan (FMP) Update, which builds on the development framework of the 2017 FMP. During the Committee on Finance's February 2 meeting, UMB President Bruce Jarrell shared an update on recent progress, including the completion of the Health Sciences Research Facility III, the Community Engagement Center, and the first phase of a campuswide electrical infrastructure project. In addition, a site has been cleared for the planned new School of Social Work building, which represents a large step toward realizing the north campus revitalization goals. The 2022 FMP Update anticipates future facilities growth, continues efforts to enhance the campus environment, and focuses on forming new connections with neighboring communities and partner institutions, as well as improving connections between UMB's south and north campuses.

### JACOB ASHBY JOINS THE USM AS EXECUTIVE **DIRECTOR OF THE UNIVERSITY SYSTEM OF MARYLAND AT HAGERSTOWN**

Last month, Chancellor Perman appointed Dr. Jacob Ashby as the next executive director of the University System of Maryland at Hagerstown (USMH), following an extensive search led by Frostburg State University Vice President for Student Affairs Artie Travis in coordination with the USM Office leadership. Dr. Ashby has strong ties to both Hagerstown and Western Maryland; he previously served as he assistant dean of academic assessment and articulation at Frederick Community College (FCC) and also served as an adjunct instructor and a lecturer at both FCC and Hagerstown Community College.
