Board Actions & Decisions | November 22, 2019

The USM Board of Regents met at the Universities at Shady Grove on Friday, November 22, 2019. At this meeting, key actions by the Board included:

Board of Regents Chair Linda Gooden Congratulates Incoming Chancellor Jay Perman, MD, and Thanks Chancellor Robert Caret for His Service. At the meeting opening, Chair Linda Gooden commended the selection of UMB President Jay Perman, MD, as the next USM chancellor. "Jay has been an exceptional and innovative leader at UMB for over ten years—creating ties to both the city and state of Maryland—and we look forward to even greater achievements during his tenure as our new chancellor," said Gooden. Next, she thanked current Chancellor Bob Caret for his leadership and many accomplishments over the last five years. "He has greatly increased system enrollment and maintained affordability, and the USM has become more diverse and inclusive than ever before," said Gooden. "Under his leadership, the USM's role as an economic engine for the State of Maryland has grown. Bob has championed the "B-Power" initiative. He has also made civic engagement a strategic focus for USM as part of his strategic plan for the system."

Approval of New Programs at the University of Baltimore and the University of Maryland, College Park: After reviewing the recommendations of the Committee on Education Policy and Student Life, the Board voted to approve a Bachelor of Arts in Legal Studies at the University of Baltimore and the following new programs at the University of Maryland, College Park (UMCP): Bachelor of Arts in Immersive Media Design, Bachelor of Science in Immersive Media Design, Bachelor of Arts in Religions of the Ancient Middle East, and Doctor of Public Health. <u>Read More.</u>

Approval of Proposal for the University of Maryland Eastern Shore to Use Standardized Tests as an Optional Criterion for Admission: The University of Maryland Eastern Shore requested exception to the <u>BOR Policy.III-4.00</u> – Policy on Undergraduate Admissions to conduct a one-year pilot study using standardized tests as an optional criterion for admission for first-year students with an overall high school minimum grade point average of 3.4, to begin effective Fall 2020. The policy change would still require all students to submit their test scores, even if they are not used as admissions criteria. The board voted to approve this pilot study. <u>Read More.</u>

Approval of New Policies on Enterprise Risk Management and Crisis Management. The Board approved two new policies proposed by the Audit Committee. The Enterprise Risk Management policy formalizes the expectation that each institution, regional higher education center, and the System Office develop processes to periodically identify, review and assess significant strategic, financial, operational and reputational risks. The Policy on Crisis





Management formalizes the expectation that each institution, regional higher education center, and the System Office develop processes and protocols for responding to negative unanticipated events and that there be an organization-wide understanding of the response process or protocol. <u>Read More.</u>

Amendment of USM Policy on Affirmative Action and Equal Opportunity: The board voted to update the current Policy on Affirmative Action and Equal Opportunity (<u>VI-1.00</u>) and rescind two related policies to establish a comprehensive, streamlined policy on nondiscrimination. The new <u>Policy on Non-Discrimination and Equal Opportunity</u> is consistent with current law and prohibits discrimination against members of all legally protected classes of individuals. <u>Read more</u>.

Authorization of Several New and Increased Capital Expenditures: The Board authorized funding for the acquisition of property by Salisbury University and the construction of student housing on this property. In addition, the Board approved funding increases for several previously approved construction projects, including two new student housing buildings and a North Dining Hall replacement at UMCP. <u>Read More.</u>

Other News from the System

USM Independent Review of UMCP Adenovirus Response Finds Campus Followed Recognized Federal, State and Campus Health Protocols. The independent experts tasked by the Board of Regents with reviewing the University of Maryland, College Park's response to the presence of adenovirus on campus during the Fall 2018 semester have concluded that campus officials followed recognized federal, state and campus protocols in their efforts to inform the campus and maintain a healthy campus environment. As part of this determination, the experts did make several recommendations for handling similar campus situations in the future. Read more.

USM Institutions are Among the Nation's Most Affordable Colleges and Universities. Tuition prices and student-debt levels for USM institutions remain below national averages. The <u>2018 Trends in College Pricing</u> showed public in-state tuition and fees in Maryland to be below the national average for the 2018-19 academic year--\$9,474 versus \$10,230. USM data show nearly half of in-state baccalaureate recipients in 2018 completed their college experience with zero debt—with another 12 percent graduating with debt levels of less than \$10,000. This is substantially below the \$29,200 national average for 2018. <u>Read more</u>.

Maryland Momentum Fund Invests in Minnowtech Seed Funding Round. Minnowtech, LLC, an aquaculture technology company enabling shrimp farmers to image shrimp abundance with precision, received a \$150,000 joint investment from the USM Maryland Momentum Fund and the University of Maryland Center for Environmental Science (UMCES) to complete the company's \$600,000 seed funding round. <u>Read More.</u>
