



CHANCELLOR EMERITUS DONALD N. LANGENBERG is a groundbreaking physicist and nationally-recognized leader in K-16 education. He headed the University System of Maryland from 1990 to 2002, where he worked to establish a vigorous K-16 partnership devoted to improving the quality of education across Maryland and the nation. Dr. Langenberg has also served as chancellor of the University of Illinois at Chicago and vice provost for graduate studies and research at the University of Pennsylvania. He earned degrees in physics from Iowa State University; UCLA; and the University of California, Berkeley. For about a decade after his formal retirement, he remained active at the University System of Maryland and nationally in a variety of efforts to improve teaching and learning. Now he is spending most of his time reading history books and enjoying his family.

HANNAH COLE-CHU is a third-year student at the University of Maryland Francis King Carey School of Law. She is the editor in chief of the *Maryland Law Review* and a board member of the Maryland Public Interest Law Project, a student-run non-profit organization at the law school. During her time in law school, Hannah interned for the Honorable Richard D. Bennett of the U.S. District Court for the District of Maryland and at the Public Justice Center in Baltimore. She also worked as a summer associate at Arnold & Porter Kaye Scholer LLP, a law firm in Washington, D.C. Her case note, *Zivotofsky v. Kerry: Choosing International Reputation over Separation of Powers*, which analyzed the reasoning of a then-recent Supreme Court case concerning executive power in foreign affairs, was published by the *Maryland Law Review* in 2016. After graduation, Hannah will begin a judicial clerkship with the Honorable Alvin W. Thompson of the U.S. District Court for the District of Connecticut.

LUCY A. DALGLISH is a professor and dean of the Philip Merrill College of Journalism at the University of Maryland. A former journalist, lawyer, and non-profit executive, Dalglish started her academic career in 2012 after serving for 12 years as executive director of the Washington, D.C.-based Reporters Committee for Freedom of the Press, a non-profit organization that provides legal defense and advocacy services for journalists working throughout the United States. Dalglish also has worked as a trial lawyer at the Minneapolis-based firm Dorsey & Whitney and as a reporter and editor at the *St. Paul Pioneer Press*. She has law degrees from Vanderbilt and Yale Universities and a bachelor of arts in journalism from the University of North Dakota.

MARGARET E. JOHNSON is a professor of law; co-director, Center on Applied Feminism; and director, Bronfein Family Law Clinic at the University of Baltimore School of Law. Her scholarship primarily focuses on social justice, feminist legal theory, and systemic reform issues relating to domestic violence and the legal system. Professor Johnson's forthcoming book focuses on lawyering and narrative theory and is entitled *Lawyers, Clients & Narrative: A Framework for Law Students and Practitioners* (Carolina Academic Press). Professor Johnson's scholarship has been cited in court opinions and by the media. She is immediate past co-president of the Clinical Legal Education Association and a former long-term board member of the Women's Law Center of Maryland. Professor Johnson was named one of the Top 25 Women Professors in Maryland in 2013 and is the recipient of a 2012 USM Board of Regents' Faculty Award for Public Service. She was selected as Professor of the Year by the UB Women's Bar Association in 2008 and 2011.

ALAN C. MILLER, a Pulitzer Prize-winning journalist, is the president and CEO of the News Literacy Project. He was a reporter with the *Los Angeles Times* for 21 years before leaving the paper in March 2008 to establish the project. He spent nearly 19 years in the paper's Washington bureau, the last 14 as a charter member of its high-profile investigative team. His work prompted investigations by the Justice Department, Congress, and inspectors general in federal agencies and led to congressional hearings, reforms, and criminal convictions. He received more than a dozen national reporting honors, including the George Polk Award, the Goldsmith Prize for Investigative Reporting, and the Investigative Reporters and Editors Medal for breaking the 1996 Democratic National Committee campaign finance scandal. His series on the Marine Corps Harrier attack jet won the 2003 Pulitzer Prize for National Reporting. A Phi Beta Kappa graduate of Wesleyan University. Mr. Miller received a master's degree in political science from the University of Hawaii.

LINDA S. MORRIS is enrolled at the Francis King Carey School of Law at University of Maryland, Baltimore. Ms. Morris has distinguished herself as a public service leader through her initiative, commitment, and interest in making a difference as a civil rights attorney, particularly in the area of racial equality and criminal justice. Starting as a first-year student, Ms. Morris has taken a leadership role in the Maryland Public Interest Law Project, a student-run organization focused on increasing awareness of and participation in public service legal work. Ms. Morris has worked with other law students to raise funds to provide public interest summer grants each summer for 28 public service law students. In addition, Ms. Morris currently serves as a legal extern for the NAACP Legal Defense and Education Fund. Over the past two years, Ms. Morris has worked with students at Mergenthaler Vocational-Technical High School as a volunteer mock trial coach and as a teacher's assistant with the Community Law in Action's Law and Leadership Academy.

BRIAN STELTER is the host of *Reliable Sources*, which examines the week's top media stories every Sunday at 11:00 a.m. ET on CNN/U.S., and the senior media correspondent for *CNN Worldwide*. Stelter reports and writes for CNN/U.S., CNN International, CNN.com, and CNNMoney.com on a regular basis. Prior to joining CNN in November 2013, Stelter was a media reporter at *The New York Times*. Starting in 2007, he covered television and digital media for the Business Day and Arts section of the newspaper. He was also a lead contributor to the *Media Decoder* blog. Stelter graduated with a bachelor's degree in Mass Communications with a concentration in Journalism from Towson University in 2007. He is on the board of Baltimore Student Media, a nonprofit that publishes Towson's independent student newspaper, *The Towerlight*.

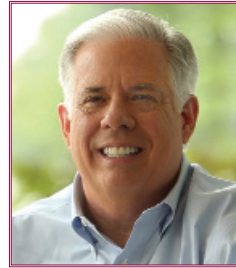

SENATOR BARBARA MIKULSKI was raised in the Highlandtown neighborhood of Baltimore, attended Catholic schools, and was a social worker in the 1960s. After organizing neighborhoods to fight a major highway project, Mikulski won election to the Baltimore City Council in 1971, where she served for five years. In 1976, she ran for Congress and represented Maryland's 3rd district for 10 years. Senator Mikulski became the first Democratic woman senator elected in her own right in 1986. She is the longest-serving woman in the history of the United States Congress and is the longest-serving senator in Maryland history. Nicknamed "the Dean of the Women," Mikulski mentored other women senators through her bipartisan dinners and power workshops to train newly elected women. Throughout her career, Mikulski has worked to pass legislation to protect the most vulnerable members of society and to advance scientific research and democracy around the world. Senator Mikulski retired from the U.S. Senate on January 3, 2017. She accepted a position as Homewood Professor of Political Science at Johns Hopkins University, and she participates in national speaking engagements on the topics of leadership, innovation, and women's empowerment.
