NOTE: UMGC and UMB use all credit hours in FTES computation. All other institutions use only fall and spring credit hours in the computation of annualized FTES. For FY 2015 and part of FY 2016, USM and UMGC FTE increase reflects the stateside consolidation of all UMUC online course administration. Beginning in the last half of FY 2016, USM and UMUC FTE further increased after Middle States approved UMGC accreditation changes that now counts overseas instructional sites as additional locations.

*The FY 2020 UMB FTE was revised to the lower 6,859 instead of 7,118. The Total USM FTE was revised to 130,177.
