#### a. Awards:

## d. Legislative Affairs

Holly shared that the committee has been working on collective bargaining rights. She wants to bring it up at the next CUSF meeting. The chair of the senate at Frostburg attended legislative affairs meetings. According to Holly, there are concerns for leadership at Frostburg. Frostburg is facing a retrenchment issue. The chair of the senate at Frostburg is supposed to send a report.

#### e. Research

Tom shared that for the past 2.5 years, the Research Committee has been considering the proposal for a USM-wide Research Portal system, consisting of a web database where faculty researchers could share: 1) research topics, 2) research approaches or techniques, and 3) contact info.

There are two major challenges:

- a) The creation and maintenance of the website and
- b) The participation of a substantial percentage of faculty researchers on the Research Portal.

Tom shared that we have the tentative support of the Vice Chancellor for Research, Michele Masucci, though there are still mechanical and fiscal issues to address. While the CUSF Research Committee can make substantial progress on these fronts, the interest among USM faculty is difficult to assess.
