	Report from USM and Questions 10:20-10:30 Alison Wrynn, USM Senior Vice Chancellor for Academic and Student Affairs or Kelsey Beckett, USM Chief of Staff and Director of Operations, USM Academic and Student Affairs. Alison encouraged campuses to vote and dialogue respectfully during election season. Situation in the middle east must also be treated cautiously and civilly, respecting both sides of the issue. Additionally, she encouraged more work on Artificia Intelligence.		

5. Chair Updates

USM paid for Ex Com members to train on Roberts rules. These rules enable streamlining meetings and agenda items. ExCom is an advisory body to the Chancellors office so has to work accordingly. In the upcoming year's budget considerations must be considered in decision making across campuses. Nagaraj mentioned that meeting dates must be consolidated in one place.

Alison is still working on the "dismissal of faculty issue." Speaking to Provosts this week. As a system they can sometimes support universities financially. However, Presidents oversee universities. There have been enrollment challenges especially among the HBCUs but this is starting to change. USM finances have not been as bad as other neighboring systems.

The USM Strategic Plan has 5 pillars which includes academic excellence and innovation. Enrollment and diverse issues with older students, as well as growing Latinx population across campuses was encouraged. Campuses must consider thinking differently to attract a greater number of people. Broad humanities and civic education though still valuable but consideration must be given to the fact that graduates must find jobs. Alison also emphasized a strong focus on research. Diversity, equity, and inclusion is still valued in the USM.
