#### 1. WELCOME AND INTRODUCTIONS

- Peter Gilbert, Vice President for Planning and Accountability, welcomed CUSS to the University of Maryland, Baltimore
- 2. APPROVAL OF MINUTES
  - Minutes for both July and August 2010 were approved as amended
  - Mary Reed passed around the membership list from the CUSS website for confirmation/corrections
- 3. VICE CHAIR'S REPORT
  - CUSS and CUSF will hold a full joint meeting, approved for Nov. 16 at the University of Maryland, College Park
    - o Dr. Loh, the new president of the University of Maryland, College Park, will attend
    - o All members and alternates are encouraged to attend

- Board of Regents Ad Hoc committee met to finalize information for packets to be distributed to all Institutions imminently
- Roy Ross will serve on CUSF's collective bargaining panel on Oct. 14
  - CUSF is looking into the possibility of collective bargaining
  - They have lots of unanswered questions
  - They're hoping Roy Ross can share the CUSS perspective and experiences
  - Colette Becker attended the Presidents Council meeting; collective bargaining was on the agenda, but it was pulled off the table
  - CUSF is split half and half in support of collective bargaining
- VOTE: bylaw revision
  - Gus Mercanti submitted a proposal to remove the 2,000 Staff employees member cap from the apportionment to make three representatives the maximum
  - APPROVED (Dave DeLooze made the motion; Sister Maureen Schrimpe seconded)
- Wiggio
  - o Only useful if everyone commits to using it
  - Wiggio is useful because it consolidates information and avoides multiple listserv emails
  - Providing rough timeframes for responses on Wiggio—when responses are necessary—would be helpful
  - o DECISION: continue use of the listserv; perhaps use Wiggio for committee work
    - Wiggio is useful as an archiving tool
    - If we decide to use Wiggio, all members need to be committed to utilizing it for the prescribed purpose
  - ACTION: Colette Becker will send the Wiggio link to the CUSS listserv again so members can familiarize themselves with the tool
- Board of Regents Awards runner-up certificates have been completed and mailed
- Orientation
  - Roy Ross distributed a packet of legislative information
  - o If needed, orientation will be done at the October meeting
  - o Mary Reed: Anyone who's new should participate in orientation
    - Website Standing Committees page is a pain because of the ongoing process of assigning people to committees; it makes upkeep difficult
    - DECISION: we will not list standing committee membership on the Web; we will list on the names of the committees and their charges; this will reduce work for Mary Reed and CUSS to keep membership lists up to date
  - ACTION: Ongoing orientation
    - Announce new members during Welcome and Introductions at every meeting, since each Institution holds elections at different times of year; it's incumbent upon CUSS members in attendance to ask if there are any new members
    - Take 15-20 minutes during lunch to orient any new members in attendance

- Keep a couple of orientation packets on hand at all times
- Put original packet files on Wiggio for archiving and access to membership only
- Welcome letters to all new members go to presidents, supervisors and members
- Mary Reed needs backup—it's a lot of work
- Review newsletter
  - Colette Becker will distribute newsletter Sept. 29 or 30
  - Send any necessary updates to the newsletter no later than the morning of Sept. 29
- 4. CHANCELLOR'S LIAISON REPORT
  - Blue Ribbon Commission
    - MarylandReporter.com article regarding new Pension Fund Commission: report due by June 2011 with recommendations implemented by 2013
    - Blue Ribbon Commission is looking at responsibility/promise of State to retirees, which is about \$20 billion and growing
    - Pension Fund Commission (Public Employees and Retirees Benefit Sustainability Commission) is looking into State retiree benefits and pension; first meeting is Oct. 7 in Annapolis
    - Health-care reform will also impact everything
    - Commissions will be looking at cutting back
  - Board of Regents approved tuition remission benefit for same-sex spouses (not domestic partners); retroactive to July 1, 2010
    - Pending to be addressed:
      - sick leave policy (bereavement)
      - FMLA: policy based on federal law and federal government hasn't accepted same-sex spouses
      - Nepotism
  - Rosario Van Daalen reminded the council that Board of Regents policy allows State employees to serve as election judges
- 5. BOARD OF REGENTS AWARDS
  - Ad hoc committee met
  - Effectiveness and Efficiency category: NEW
    - Two categories: academic transformation and administrative transformation
      - Everything has to be documented
      - Some effectiveness and efficiency initiatives are carried out by a group of people, not just individuals
      - Colette Becker: Should we hold off on introducing this new category?
      - Brenda Yarema: If the Board of Regents is giving \$1,000 to Faculty for the category, let's take it and run with it for Staff
      - Colette Becker: We need criteria to be fleshed out; should we offer it as a group award?

- Faculty have 18 awards; Staff have six
- How should we judge the category?
- ACTION: move forward with the category as is, and we can revise it in the future
- Do awards unfairly target supervisors? Yarema, TU
- VOTE: include Effectiveness and Efficiency award as either a group or individual award; flexibility to decide how we want to award it (Sister Maureen Schrimpe made the motion): APPROVED
  - Goes to Board of regents as a recommendation
- Clarification of eligibility requirements
  - Tweak wording of third bullet: Nomination must be made with the knowledge and consent of the nominee (positive rather than negative language)
- Rosario Van Daalen: look at criteria of awards to determine whether *all* staff are eligible for awards; there are some positions that seem they'd never be eligible
- o Deadlines
  - Goal is April Board of Regents meeting; all review has to be done by mid-March
  - Submit nomination packets by Jan. 21, 2011
- Ad hoc committee commended for work done
- o ACTION: Packet will go out as soon as Colette Becker and Willie Brown can coordinate
- 6. MESSAGE TO LEGISLATURE (CAPWIZ)
  - A Day in the Life
    - o Add: direct/manage, am in contact with (instead of "call the"), support
    - What will CapWiz look like? Does it need additional clarification information in the introduction?
    - Hardship stories can be included—what have we done to help our own?
    - ACTION: Dave DeLooze will e-mail Word document of message to Giordana Segneri for edits
  - Roy Ross will need to write his letter about SB 141
  - Colette Becker and Willie Brown will set up a meeting next week with PJ Hogan to discuss CapWiz
- 7. COMMITTEE MEMBERSHIP
  - All members determine on which committees they'd like to serve
  - Are we keeping current committees as they are?
  - Break out to review missions and determine activities for the coming year
    - o Executive Committee
      - Melissa Stein will be Member-at-Large instead of Ayman Abdo, who is resigning from CUSS; Melissa Stein received the third most votes in the original election
      - Brown, Becker, Van Daalen, Segneri, Schulz, Mercanti, Stein
    - o Benefits and Compensation
      - Mathis, Reed, Schrimpe, Boobar, Stevenson (chair)
    - o Communications

- Logistics of getting website and listserv up to date need to be worked out
- o Community Development

- Need better method to accommodate remote attendance at meetings; make better use of technology

# 9. NEW BUSINESS

- Tuition remission for C2s to study at other campuses
- Taxable tuition remission issues: Rosario Van Daalen will bring up again to HR Directors and Benefits Coordinators
  - o Issued memo four or five years ago; Benefits Coordinator at Institutions can dig it up
  - Can be huge issue because employee can wind up without enough money in his or her paycheck to cover health benefits
  - NOTE: AFTER THE MEETING Rosario Van Daalen followed up with Benefits
    Coordinators and all Institutions are advising employees on a timely basis via a memo addressed directly to the employee; the notice is on the Tuition Remission form (*I hereby certify that*: footnote #4.); it is the responsibility of the employee to be aware of what they sign and of notices sent to them.
