# <u>Chair's Report – Kalia Patricio</u>

#### Welcome - President Aminta Breaux - BSU

#### **Awards & Outreach**

- Action Plan for Communication:
  - Newsletter: May 1st email request for institutional updates which are due May 10th,
     Newsletter distribution date approximately May 19th
  - o Facebook/Twitter posting ideas: Repost, highlight minutes, mention who visited at meeting, and make comments that indicate we are working.
- BOR Subcommittee met 4/13 and thinking about doing a completely separate package for Non-exempt. Basically, have 5 categories like the packet is currently, but the categories are different:
  - o Excellence in Performance
  - o Making a difference to the campus
  - o Acting as a role model for peers and colleagues
  - o Excellence as a team player
  - o Inclusion, multiculturalism, and social justice
- Questioned if the committee needed to change the categories
- Needed to figure out the criteria for grading the packets for Non-exempt
- Some categories from another university:
  - o Integrity, Trust, and Ethics Ambassadorship (representation of the department)

# **Legislative Affairs Committee**

 The MD legislative session has ended as of April 10 at midnight. A legislative session report from Patrick & Andy would be provided in the coming days that outlines accomplishments and next steps for the USMO of Governmental Relations. • There is a concern for the lack of documentation at the home institutions regarding telework policies. The results found was that at least at UBalt, Salisbury, and Frostburg there is some

- university-wide documentation going out focusing largely on staff members' ability to work remotely from out of state as this has tax-time implications. The IT Staff seemed to be the impetus for these types of documents.
- Absent any state-wide or even system-wide rules on teleworking policies, the committee would like to start a discussion with Sr. Vice Chancellor for Admin and Finance Ellen Herbst or Associate Vice Chancellor for Human Resources Carolyn Skolnik. At present, the committee would like to discuss the system's ability to enforce uniformity among new job postings to include at least expectation around hybrid, fully remote, or completely in-person work. Although there have been some new postings including this information, but the committee feels the system could do more as far as transparency in salaries and benefits such as these.
- Collecting information on the statewide Green Initiative, as well as looking to potentially change the name change to BSU's staff council.

#### Staff Resources & Special Projects Committee

#### • Tuition remission fees

- Meredith Carpenter reached out to Kalia to inform her that we would use the prior results to refocus and create a buss around the proposal for an "EXEMPTION" or "REMOVAL" of all fees only for staff (not their dependents) who take advantage of tuition remission e.g. eliminating unnecessary, duplicate and burdensome fees
  - Kalia mentioned that she thinks USM is looking to us to make the next move / update our proposal. Kalia asked is we know if any campuses instituted the request from last time since the Chancellor asked the President's to address duplicative fees.
    - We may want to reach out to the various institutions or HR/CUSS POC's to poll which campuses have/haven't removed the duplicate fees
- <u>Staff Support Programs (OMBUD, FSAP, etc.)</u> □ Brian sent out the poll to our CUSS POC's regarding which campuses have an OMBUD with a response due date of 04.21.23
  - <u>o</u> After receipt of the answers we will share the results with CUSS, as many members indicated presenting the information to their campus senate

• Telework Practices and green initiatives □ VJ sent a request to LERW and USM (Tom Hoffackner) to, at minimum create transparency of policies in addition to the previously raised questions from last month's minutes (suggested links to institution telework policies, practices and telework agreements in the format similar to how USM does with employment opportunities as well as HR Offices at <a href="https://uhr.umd.edu/telework/">https://uhr.umd.edu/telework/</a>
